#### Rent Control Ordinance

The November 6 hearing to allow a group of Tenant Associations to intervene during the pending RCO lawsuit was postponed to allow development of an amendment by the attorneys representing the petitioning Tenants' Associations. A draft memo to Mayor Baraka planned to address the substantial rehabilitation section of the RCO. However, there are problems with other areas of the RCO that also must be addressed. Rather than developing a memo that provides an amendment for only one of the RCO issues, a November 11 meeting between liaisons for the Tenants' Association and its attorneys will seek to build consensus for addressing additional RCO sections that require either strengthened language or further clarity. In the interim, the City Council will be convening on November 16 and tenants are encouraged to register to speak about rental issues or concerns with the RCO.

At the heart of the current landlord-initiated lawsuit is the revised rent control ordinance now caps any rent increase for substantial rehabilitation to 20 percent and raises the threshold for requesting that rent increase to \$5,000 per room in a given unit. Landlords claim the new rules fail to take into account the cost of maintaining their buildings and creates disincentives for making improvements to their properties. Let the Newark City Council and Mayor Baraka know you expect elected officials to defend the RCO as adopted on June 20, 2014!
